## Seeking Nominations for Board of Directors

At the regular June meeting of the Chamber Board of Directors, a nominating committee consisting of four members was appointed. The Nominating Committee is now in session and accepting suggested candidates from the general membership for positions on the Board of Directors for the 2008/2009 fiscal year. Eligibility for a position on the board includes:

- Member (or employee of a member) of the Greater Sandpoint Chamber of Commerce for at least one year
- Member in good standing

The Greater Sandpoint Chamber of Commerce Board of Directors has full control of the affairs of the Greater Sandpoint Chamber of Commerce. The government of the Chamber and the direction of its work is vested to the Board consisting of nine members, one third of whom shall be elected annually for a term of three years beginning October 1st and ending September 30th three years later, and one member representing each Program Committee of the Chamber. The maximum number of representatives on the board is nine.
